

### Small/Minority Business Enterprise (S/MBE)

#### Small Business Enterprise (SBE)

- Principal place of business in Connecticut
- Revenues not exceeding \$15M
- Independent

#### Minority Business Enterprise (MBE)

- 51% ownership by one or more minority person(s) or
- Is an individual with a disability

### **Goal Setting**

State of Connecticut Agencies and political subdivisions of the State must set aside each fiscal year, after approved exemptions by the Department of Administrative Services (DAS):

- 25% of their budgets for construction, housing rehabilitation, and purchasing supplies and services to be awarded to certified small business enterprises (SBEs), with
- **25% of this amount** to be awarded to certified minority business enterprises (MBEs).

### **Construction-Related S/MBE Utilization Goals**

25% of total project value to SBEs of which 6.25% to SBEs who are also MBEs




30% of total project value to SBEs of which 10% to SBEs who are also MBEs For Bioscience and NextGen CT University commitment


#### **Non-Construction – Related S/MBE Utilization**

# Encouraging Participation

- Strengthen visibility on the USDP Website with video and other interactive feedback tools for S/MBEs, UConn departments, contractors/vendors, and service providers
- S/MBE criteria in Professional Services design team selection
- Continue to address S/MBE Challenges

#### Educating Contractors/Vendors and University Community

- Increase the level of contact and engagement between buying teams and S/MBE vendors/service providers
- Engage and inform our University Community, including through vendor referrals, feedback mechanisms, and progressive changes to the USDP website, etc.

### Select Strategic USDP Initiatives

#### **Managing Relationships**

- Collaboratively (with other State Agencies) Engage Surety Bonding Programs for additional assistance to S/MBE's with Bonding in the State of Connecticut
